Project Description

This project will build safe walking/biking trails for recreation, linking residents to the Pound Ridge Town Park, open spaces, nature preserves, & business/cultural centers. The new trails will connect to an existing 1.2 mile paved path from Park to the Town House and on to the Business District. Future planned phases will extend these corridors.

- 1: "Old Pound Town Path Extension" will extend the Town Path from the park, winding through an undeveloped town-owned 21 acre parcel, 7 Old Pound Rd., and exiting on Old Pound Rd. This multi-use trail bypasses a steep, high-traffic section of Rt. 137 that is unsafe for walking/biking.
- 2. "Old Pound Nature Trail"will connect from the above path to the SE corner of the 7 Old Pound parcel.
- 3: The "Town Park to Halle Ravine" interpretative trail will travel through undeveloped town properties connecting the East end of the Park to Halle Ravine, a nature preserve.

This project is a huge step toward the Town's vision of a more walkable, bikeable community with non-motorized access to open spaces and the Historic District, which includes schools, a church, meeting house, library, restaurants, museum, historical buildings and shops.

Q_976 Statement of need: Provide a brief summary of the need for the project in the geographic area proposed and the project's financing needs, including funding gaps of the proposed project.

Per the 2020-2025 SCORP, Westchester Cnty has an RIN of 8 for biking. The need for safe, bikeable paths in Pound Ridge is even greater. Our roadways are narrow, with no bike lanes, particularly the section of Westchester Ave. between the Town Park and The Hamlet/Historic District. There are many instances, eg. Summer Camp, 4th of July, & Harvest Fest & other Town events, where the lack of a safe, walkable route between the Park and elementary school creates huge logistical & safety problems. Pound Ridge has

many preserves and open-spaces that lack adequate parking, though hikers are required to drive to them. The limited parking has also prevented us from using these preserves and open spaces for group recreation and educational programs. Creating access corridors will enable residents & visitors to safely & sustainably enjoy our land.

Our trail project most aligns with the RECD / URI priority goal of "grow natural resources". Pound Ridge is abundant in natural resources: trees, ponds, streams, stunning rock formations, peace, quiet, and wildlife. This project "grows" those resources by providing access to them with trails that allow residents and visitors to experience town-owned undeveloped wetlands and woodlands with minimal impact. Connected to the Town Park and Halle Ravine, these trailways will expand educational opportunities through our Summer Camp, Recreation, and Land Conservancy programs, which can "grow" these resources by teaching our kids and grownups to appreciate and protect them.

This trail project will help will make our town and region more sustainable. By making it easier for residents and visitors to walk and bike through town, we can reduce our reliance on carbon emitting automobiles. This will also revitalize the community and bring economic investment. People from greater NYC already visit or move to Pound Ridge for its unspoiled natural beauty and undeveloped charm. They come to bike our winding roads, hike in our preserves and Reservation, and "bathe" in our forests. By making safe connections for walking and biking between shops and restaurants in Scott's Corners, the playgrounds, pools, and fields of the Town Park, the woods and wetlands of our open spaces, and the historic charm of the Hamlet, we can enhance Pound Ridge's appeal as a destination for daytrippers, weekenders, & anyone looking for an escape from the megalopolis just 45 minutes to the South. Those visitors will spend money in our shops and restaurants downtown.

The "Town Park to Halle Ravine" trail is intended for walking, interpretative/nature, and snowshoeing. The trails we build will connect to and build upon the existing paved Town Path, which mostly runs between Westchester Avenue and a stream/wetlands owned by Aquarion Water Company. The new trails will extend this corridor by connecting to and through other open spaces. This will maximize the use of this corridor, while maintaining its integrity and minimizing impact to wetlands and woodlands.

The proposed new "Old Pound Town Path Extension" furthers the goal of creating a Pound Ridge Trail System by beginning to connect the Park to the Historic District, aka "The Hamlet", a cultural center of town which includes the Pound Ridge Elementary School, Community Church and Pre-School, Historical Society and museum, the Library, Conant Hall (a Town-owned facility used for various community services and gatherings), as well as the Inn at Pound Ridge. Currently, there is no safe route between the Town Park and the Hamlet because that section of Route 137 is steep, heavily trafficked, and too narrow for sidewalks or bike lanes. The "Old Pound Town Path Extension" also creates recreational access to the 21 acres of undeveloped scenic woodlands on the "7 Old Pound" property, which currently has no viable means of access. The "Old Pound Nature Trail" will allow for more walking amidst nature on the property, and may eventually provide an additional access point for a scenic route to other trails in the Park. The "Town Park to Halle Ravine" Trail links the Town Park through an undeveloped parcel of Town-owned land to 1.2 miles of trails in the Halle Ravine Nature Preserve.

These new trails, linked to the existing paved trail that goes from the Park to Scott's Corners (the town Business District), connect the Hamlet, Park, Nature Preserves, the Town House, and Scott's Corners in a continuous, safe, car-free "greenway".

The "Old Pound Town Path Extension" will improve the continuity of our Town's existing paved trail. It will add approximately .65 miles to the existing 1.2 mile paved trail, bringing us closer to a crucial connection between the Hamlet, Park, and Business District, which

has an additional .5 miles of paved sidewalks. The "Town Park to Halle Ravine" trail will connect the Town Park to one of the Town's largest and most used Nature Preserves, adding 1 mile of trail that connects to 1.2 miles of existing hiking trails in Halle Ravine. All told, these trails will comprise a network of over 5 miles. Per longstanding Town goals, we envision expanding this system in future projects through the Hamlet to more residential neighborhoods and existing trail networks. In a town with no public transportation, this is a crucial step towards our vision of a community that can be safely traversed without a car.

a. The Old Pound Town Path Extension access point was chosen as the most accessible option for persons with disabilities. However, small sections of the route, particularly the entry point from Route 137 to the 7 Old Pound Property, are slightly more steep than ADA thresholds allow. In the RFQ phase, engineers will be asked to investigate ways to achieve ADA compliance. b. The "Town Park to Halle Ravine" route begins in the Town Park near a old blue blazed trail that ultimately disappears. This trail is mentioned and mapped in "Walkable Westchester" (J. & W. Daniels, 2nd edition, 2014, page 89), but it did not go all the way through the Fox Run property to Fox Run Rd., and it has not been maintained. Many people currently bushwhack their way through this parcel of land, trying to get through to Fox Run Road. By redesigning, completing, and marking this trail, we can minimize impact to wetlands and threatened species. c. We have been advised by and will utilize the Service Corps of the NY-NJ Trail Conference to assist in training and trail building.

All proposed work to enhance and connect our trails are currently on property owned by the Town of Pound Ridge, or we have right of way on our local roads and approval from NYSDOT.

We are not proposing to change any designation. We are proposing to create pathways to connect existing trails, preserves and parklands to increase accessibility, safety and sustainability.

Q_9727 Describe the relationship of the proposed project to any significant environmental resources, including wetlands and floodplains. Include the type and size of the resources and how they will be managed and impacted.

The proposed "Town Park to Halle Ravine" trail will have sections that interact with state regulated wetlands and fall within the vicinity of the NYSDEC's "Animals Listed as Endangered or Threatened or Rare" buffer area. Permits will be required for both wetlands and endangered/threatened species. The "Old Pound Town Path Extension" trail will not cross wetlands, but will require a permit due to its "Animals Listed as Endangered of Threatened" status.

The "Town Park to Halle Ravine" trail passes through a "Class 2-State Regulated Freshwater Wetlands", system. The "Wetland ID" for this particular wetland is "D-10". The size of this wetland system is 55.9 acres. However, the route has been chosen to minimize wetland crossing to some 420 linear feet. To traverse these sections, 420 feet of 3 foot wide boardwalks and bridges have been planned and designed with the guidance of members of the NY-NJ Trail Conference. Apart from the footings of boardwalks and bridges, the wetlands will be minimally impacted, as hikers will stay on the boardwalk. This is an ecological improvement from the current situation, in which hikers frequently bushwhack though unmarked wetlands in attempt to get to the Town Park or Halle Ravine. The stone dust path through "7 Old Pound" will be routed through sparse woodlands to minimize any disturbance of trees and other potential habitats.

The entrance into the "7 Old Pound" property from Westchester Avenue will require some grading of the the steep roadside embankment leading up to the property in order to make the path an acceptable grade for walking and biking. There may be small sections of trail that may require some minor cutting and filling due to grade, to prevent erosion of the trail and avoid damage to the surrounding ecosystem. The section of the path running along Westchester Avenue will be engineered to ensure runoff from the road is properly diverted.

This project is a crucial piece of a larger, long term Town goal of creating trail systems that link Pound Ridge's open spaces, recreation areas, business centers, cultural hubs, & neighborhoods via "greenways" that provide safe, minimally impactful access to the Town's natural and cultural resources.

The 2023 RTP grant funding will be used to build trails connected to the Town Park and an existing paved corridor trail.

I. The "Old Pound Town Path Extension" (OPPE) will run 4278' from the Park to and through the undeveloped town-owned 21 acre parcel at 7 Old Pound Road.

The OPPE will start at the northern terminus of an existing 1.2 mile paved path near the pond on West end of the Park. The new trail will head West, and run 343' around the edge of the parking lot as a 6' wide painted bike lane until the NW corner of lot. The trail will then become a 6' wide asphalt path, running East for 400' along the North edge of the parking lot. 200' of the trail on NE side of lot will be lined by concrete curbs to keep cars off trail & maintain existing parking spots. 40' from Rt 137, a guardrail will be installed to separate trail users from vehicle traffic and funnel them safely onto the trail as it approaches Rt. 137. At NW corner of lot, the trail will become stone dust and turn North on Rt 137, running along West roadside where Town has NYSDOT approval to use ROW. Guardrail will wrap around this corner and continue between the trail & road with gaps for 2 driveways crossed. Signage and speed controls will be installed in this area to keep cyclists from colliding with cars as they head downhill. After traveling 400' up Rt. 137, the trail will switch back to minimize grade as it climbs the embankment between Rt 137 and 7 Old Pound property. Path will then turn East into 7 Old Pound land through an existing gap in the stone wall. Trail will wind East and North through 7 Old Pound property, turning repeatedly to minimize slope, go through existing gaps in stone wall, avoid trees, & end at Old Pound Rd.

- 2. The Old Pound Nature Trail (OPNT) will be a 750' interpretive hiking trail off the OPPE near SW corner of private lots #9820 15.1 & 15.2, terminating at the SW corner of the 7 Old Pound Property.
- 3. The "Town Park to Halle Ravine" (TPHR) trail will be built from East end of Town Park to SW edge of Halle Ravine Preserve trails, a total of 1.05 miles. The TPHR trail will begin by the tennis courts, and head East for 2369' through an 8.03 acre town-owned lot to Fox Run Rd. Volunteers will build a 3' wide hiking trail. Wetlands will be traversed by building 420 total linear feet of 3' wide boardwalks & bridges. The trail will then head WNW along Fox Run Rd., a very quiet back street, for 456' until the intersection with Indian Hill Rd. Then North on Indian Hill Rd. on a grassy stretch on the roadside for 500'. The trail will then enter another town-owned lot, where a 20' bridge will be constructed to cross a stream. The trail will continue North for approximately 1379', enter Halle Ravine Preserve & connect with the Southern Loop of existing Halle Ravine trails.

PLANNING AND DESIGN:

Jason Pitingaro, Town Engineer, designed original plan for OPPE trails in 2021, with guidance from Old Pound Road Advisory Committee (OPRAC). In 2023, he redesigned plan to make access to OPPE via Rt. 137 safer.

Pound Ridge Land Conservancy Land Stewards were consulted on optimal routes for trails to minimize environmental impact & coordinate plans with PRLC.

Members of the NY-NJ Trails Conference walked the properties and shared expertise & resources to help plan trails and design boardwalks & bridges in line with safety & environmental standards.

Plans for OPPE conform to all applicable building, safety, & environmental standards. Project manager will oversee hiring of contractor to execute plans in line with standards.

NYNJTC will train volunteer builders of TPHR & OPNT trails, ensuring the completed project adheres to applicable environmental & safety standards.

The items outlined in the Cost Share Summary & CFA program budget provide for construction of trails that are as accessible, safe, and ecologically friendly as possible.
