- I. CALL TO ORDER OF REGULAR MEETING: Supervisor Hansan called the meeting to order at 7:40 pm.

# III. PUBLIC COMMENT I

Resident John Nathan, of 155 Upper Shad Road, questioned the process for resident input on the proposed legislation to regulate cannabis retail business activity.

Resident John McCown, of 25 Miller Road, presented a list of 47 individuals who support incorporating the following items in any cannabis-related zoning changes:

- Prohibiting cannabis retail business activity in the business district known as PB-A
- Requiring at least 2,000 feet between cannabis businesses
- Limiting operation of cannabis businesses to ten hours daily and prohibiting operation after 8:00 pm

> Resident and Zoning Board of Appeals member Joseph Gunset, of 146 Upper Shad Road, encouraged the Town Board to engage in as much public discussion as possible regarding the proposed legislation so that there will be a record of the board's intent.

Supervisor Hansan pointed out that the presentation by Hardesty & Hanover is only the first step of a multi-step process and that there will be at least one formal public hearing.

Resident Catherine Nathan, of 155 Upper Shad Road, asked when the public hearing would be scheduled. Supervisor Hansan responded that that a date would be set later in the meeting.

# A. Hardesty & Hanover presentation on draft legislation to regulate cannabis retail business activity

Malcolm Simpson, a planning consultant at Hardesty & Hanover, presented a first draft of possible legislation to regulate cannabis retail business activity in the business district. He noted that the state is responsible for all cannabis licensing and most regulation.

Many municipalities that did not opt out of cannabis retail business activity do not have specific regulations because the state has already imposed extensive regulation. However, it may be desirable to duplicate regulations that are already in place at the state level because state regulations may be liberalized in the future. Other topics discussed included hours of operation, distance requirements, parking, building façades, and the possibility of Planning Board waivers.

Ms. Nathan pointed out that there is a spotlight in front of the dispensary at 32 Westchester Avenue that may have been installed recently. Town Attorney Harrington said that the spotlight was in place when the building was occupied by a prior tenant.

Resident Michele Braun, of 2 Pheasant Lane, asked what communities Mr. Simpson had looked at in developing his proposal and questioned the applicability of regulations from Peekskill and Poughkeepsie. Mr. Simpson said that he had examined municipalities in the Hudson Valley and beyond but that most had imposed no regulations beyond those already promulgated by the state. He said that Peekskill and Poughkeepsie were relevant, despite being dissimilar to Pound Ridge in many ways, because they have robust regulations. Mr. Simpson will produce a revised draft that includes input received thus far. That draft is tentatively scheduled to be presented at a public information session at the September 17 meeting.

Speaking on behalf of the Pound Ridge Fire District, Mr. Sacks asked whether the Fire District properties in the business district will be subject to assessment as part of the proposed fire district. He also asked if specifics regarding water mains and fire hydrants could be shared with the fire district.

Councilperson Boak indicated that when he returns from vacation, the consultant from Laberge will be available to meet with the fire department and fire district regarding these issues. Supervisor Hansan also noted that in the interim, much of the specific information Mr. Sacks is requesting can likely be found in the map, plan and report posted on the town website.

Supervisor Hansan asked Mr. Sacks if there were any updates on construction at the fire house, and Mr. Sacks suggested that he speak with representatives of the fire district.
