Re: Request to Award Fuel Oil and Recyclables Bids

1. Fuel Oil

A bid opening for #2 fuel oil was held at the Town House on Tuesday, November 9, 2021. The bid was advertised and posted, and packets were sent to multiple fuel oil companies, but only one bid was received, from Marshall Oil Company, our current supplier.

Marshall will deliver #2 fuel oil for all facilities at seven cents (+\$0.07) above the low New York Harbor Barge Reseller's price, the same price we are currently paying. The service contract fees (\$100/unit and \$50/hot water heater) are also unchanged. I recommend awarding the bid to Marshall.

2. Recyclable Materials and Household Junk

A bid opening for recyclable materials was also held at the Town House on Tuesday, November 9, 2021. This bid was also advertised and posted, with multiple packets sent to carting services. We received bids from City Carting/WIN Industries and CRP Sanitation. Below are the current rates and the bids received:

30 yards cardboard	\$150/pull	\$160/pull	\$275/pull
30 yards mixed paper	\$150/pull	\$160/pull	\$275/pull

30 yards metal	\$150/pull	\$160/pull	\$275/pull
30 yards household junk	\$500/pull	\$520/pull	\$275/pull + \$110/ton

Please note that the CRP rate for household junk is likely to be far higher than the City/WIN rate. After consulting with Highway Superintendent Vinnie Duffield, I recommend that we award the bid to City/WIN.

Pickup of each container (one "pull") is done on an as-needed basis. During 2021, we have averaged two pulls per month for each type of material, for a total annual cost of approximately \$26,400. At the new rate, our costs will be approximately \$27,840.
