A. New York State Department of Environmental Conservation – PFAS update

Anthony Bollasina, Jason Pelton, and Brittany O'Brien-Drake of the New York State Department of Environmental Conservation (DEC) provided an update on the investigation of emerging contaminants, namely PFAS, in the business district. Because PFAS has been detected in multiple supply wells, DEC is attempting to determine whether the contamination originates from an industrial source and thus can be remediated or whether the elevated readings represent widespread, diffuse contamination from non-industrial sources that is better addressed through a community water system. A formal site characterization will be done; this work will include collection of soil and water samples at multiple depths and in multiple locations, as well as testing for additional chemicals.

B. Binghamton University – Trails project presentation

Christopher Holman, of Binghamton University, reported on the recently completed Phase 1A Cultural Resource Assessment conducted in preparation for the proposed trails project. The investigation concluded that the proposed project will not impact any significant cultural resources and that no further archaeological work is needed.
